- I agree the user will return all rental equipment by the agreed date(s) in clean condition to avoid any additional charges.
- I understand that the binding system cannot guarantee the user's safety. In downhill skiling and skilboarding with skilboards equipped with release bindings, the binding system will not release at all times or under all circumstances where release may prevent injury or death, nor is it possible to predict every situation in which it will release. In snowboarding, cross-country skiling, skiboarding with skiboards equipped with non-release bindings, snowshoeing and other sports utilizing equipment with non-release bindings, the binding system will not ordinarily release during use; these bindings are not designed to release as a result of forces generated during ordinary operation.
- I understand that the sports of skiing, snowboarding, skiboarding, snowshoeing and other sports (collectively 'RECREATIONAL SNOW SPORTS') involve inherent and other risks of INJURY and DEATH. I voluntarily agree to expressly assume all risks of injury or death that may result from these RECREATIONAL SNOW SPORTS, or which relate in any way to the use of this equipment.
- I understand that a helmet designed for RECREATIONAL SNOW SPORTS use will help reduce the risk of some types of injuries to the user at slower speeds. I recognize that serious injury or death can result from both low and high-energy impacts, even when a helmet is worn.
- I understand and am aware that no helmet can protect the wearer from all impacts.

There are elements of risk in skiing and riding that common sense and personal awareness can help to reduce. Please read the following code and additional guidelines to ensure a winter of safe skiing and riding fun for everyone.

### **Shawnee Peak Skiers and Riders Responsibility Code**

- 1. Ski and ride under control and in such a manner that you can stop or avoid other skiers or objects.
- 2. When skiing downhill or overtaking another skier, you must avoid the skier below you.
- 3. You must not stop where you obstruct a trail or are not visible from above.
- 4. When entering a trail or starting downhill, yield to others.
- 5. All skiers shall use devices to help prevent runaway skis or snowboards.
- 6. You shall keep off closed trails and posted areas and observe all posted signs.
- 7. If not familiar with use of lifts, ask attendant for instructions.

### In addition to the code please remember:

- Ski at a safe and responsible rate of speed at all time, especially on crowded trails, on beginner trails, or in congested areas.
- Avoid skiing in packs.
- Always use appropriate language and behavior. Always treat others with respect.
- Always use safety bars when on lifts.
- Tickets, coupons, vouchers or passes are not transferable and may not be given or sold to others at any time.
